- Benefits are reduced to 50% of the original benefit at age 75, 25% of the original benefit at age 80 and to a maximum benefit of \$2,500 at age 85.
- If you choose, you can convert your coverage to an individual life insurance policy prior to losing any coverage amount.

- No medical exam.

- Just complete, sign and return your form today. Send no money.

Your coverage effective date.

- Once accepted by ReliaStar Life, you'll receive the first bill along with your Certificate of Insurance.
- Your Coverage will start on the first day of the month following receipt of your first premium payment.
